



Ahyssa moved to the U.S. in 2010 to pursue the “American dream.” After a decade, that still hadn’t come into focus for her. She was previously a business development representative for an orthopedic office, ran a jewelry business, and worked in restaurants. “I was feeling stuck, and unhappy working a job where I was building someone else’s dream.” She reached out to a friend on Instagram, 6A2 Ciara McCormack, who introduced her to Enagic and Kangen Water®, which led to a more fulfilling life and career.



Nana Hidari earned first place for young women in the tournament. Goka Tamashiro, a first-year student at Enagic Sports High School, ranked third place.




