TERMS AND CONDITIONS / SYARAT-SYARAT DAN PERATURAN

1. This programme is opened to all BIMB ("the Bank") VISA/Mastercard Cardmember(s) ("Cardmember") with a valid Card Account and is in good standing at the point of purchase.
2. The Cardmember will be notified on the approval of his/her Easy Payment Scheme ("EPS") Application at Merchant's point of sales. The Cardmember's signature on the Direct Debit Authorization ("DDA") Form serves as acceptance by the Cardmember of the Merchant's terms and conditions of sale, the Conditions herein, and the Bank's VISA/Mastercard Card Agreement. The Bank reserves the right to reject applications without giving any reason thereof.
3. Delivery services will be arranged between the Cardmember and the Merchant and the Bank will not be responsible for any loss damage arising from late or non-delivery.
4. Save as hereinafter provided, the Cardmember may not for the duration of the EPS terminate, seek a refund or change of any goods or service purchased.
5. Any return of goods and/or cancellation of services by the Cardmember to the Merchant shall be subject to the Merchant's terms for the return of goods.
6. Upon approval of the application, the Bank will debit the Cardmember's card account with the monthly installments payable on a monthly basis, for the duration as stipulated above. Cardmember's available credit limit will be provisionally reduced by earmarking an amount, equivalent to the purchase amount which will not be available to cardmember, but will be progressively restored on a monthly basis as repayment of each installments amount is made.
7. The Bank reserves the right to terminate the cardmember's EPS without prior notice to the Cardmember and without assigning any reason thereof.
8. The Bank at its sole discretion will demand cardmember to settle full outstanding amount due under EPS if cardmember defaults in payment of any amount due breaches any terms and conditions herein / Cardmember Agreement is deceased/bankruptcy or Card Account is terminated by the Bank for any reason whatsoever.
9. The Bank will not be liable for any inadequate, defective or damaged goods or be responsible for any dispute between the cardmember and the merchant and the Bank is authorized to debit the installments on the Cardmember's account regardless of any such dispute.
10. These conditions are in addition to the VISA/Mastercard Agreement which regulates the provision of credit card facility by the Bank to the Cardmember. In the event of inconsistency between these conditions and the said Agreement these terms and conditions shall prevail in so far as they apply to the EPS.
