Kangen Air: FAQs and Purchase Terms & Conditions

Kangen Air：常见问题与购买条款和条件

1. Definition of Identities

Kangen Account Distributor - Distributor who has purchased a Leveluk machine, Anespa, or Ukon product to join the Enagic business.

Non-Kangen Account Distributor - Distributor who has joined the Enagic business by purchasing the emGuarde, Curry set, or Kangen Air product only. These distributors have not yet purchased any Leveluk machine, Anespa, or Ukon product.

2. How much does Kangen Air cost?

The standard price is MYR 6,200 (Price excludes delivery cost). It comes in a set of 4 in Black, White, Pink, and Blue colors.

If you only purchase Kangen Air products and become a distributor (considered Non-Kangen Account Distributor), you will only receive **half (50%)** commission when you sponsor others to purchase any products. After Kangen Air product distributors purchase Enagic products themselves and become Kangen Account Distributor, commissions can be collected in **full (100%)**.
