## E. AGREEMENTS.

This agreement is made between the prospective distributors (herein referred as 'APPLICANT', 'SPONSOR' and '6A'), and Enagic® (Malaysia) Sdn Bhd ('herein referred as ENAGIC').

The clusters of prospective distributors (herein referred as 'THE PARTIES')

The Applicant hereby verified and confirmed to opt for GOOD SAMARITAN (TOKUREI) PROGRAM in connection with the purchase of the product from Enagic through SPONSOR as specified in Section B that the purchase of machine's price as specified in SECTION D shall be offset by deducting the Applicant's future commissions.

Applicant agrees that the amount to be withheld (per point) by Enagic shall consist of:

- two hundred and seventy five (MYR 275.00) for each sale of LeveLuk JRII, LeveLuk SD501, LeveLuk SD501-PT and ANESPA; and
- five hundred and fifty (MYR 550.00) for each sale of LeveLuk SUPER501.
  - 1. GOOD SAMARITAN (TOKUREI) PROGRAM is only made available towards any first time individual with limited financial status to purchase any of Enagic's machine yet desire to join Enagic as DISTRIBUTOR.
  - 2. Applicant is required to submit together with the Product Application Form for his/her own registration and sale.
  - 3. Applicant agrees to sell and submit at least one sale machine with any payment methods made available by Enagic® (Malaysia) Sdn Bhd, However, sale with GOOD SAMARITAN (TOKUREI) PROGRAM is prohibited.
  - 4. No Applicant (TOKUREI) is allowed to purchase a subsequent unit of machines and/or UKON™ until his/her current GOOD SAMARITAN (TOKUREI) PROGRAM has been fully paid off.
  - 5. Applicant agrees that the Special Points (SP) will not be allocated while the program is still in effect.
  - 6. Applicant agrees that the Special Points (SP) will only be allocated once the applicant has made a direct sale after the program has been fully paid off.
  - 7. Applicant is not allowed to downgrade his/her machine as specified in SECTION D once the program is no longer in effect.

- 8. Applicant is required to fill up the MACHINE UPGRADE REQUEST FORM for any request of upgrade.
- 9. The withheld amount is non-refundable, and may only be used by the Applicant towards the purchase specified machine in SECTION D.
- 10. In the event that the DISTRIBUTORSHIP is being <u>TERMINATED</u> involuntary or voluntary before the Applicant could purchase his/her desired machine, the withheld amount shall by default be the property of Enagic.
- 11. The agreement shall be <u>TERMINATED</u> by default once the GOOD SAMARITAN (TOKUREI) PROGRAM has been fully paid off either by accumulating the withheld commissions or by filling up the CANCELLATION OF GOODS SAMARITAN (TOKUREI) STATUS FORM and making the remaining balance payment.

The Parties hereby verified that all of the personal information and data ("Personal Data") stated above are complete and accurate. The Parties hereby acknowledge that all the personal information may be shared with Enagic® (Malaysia) Sdn Bhd's related and/or affiliated company within Malaysia or outside Malaysia for the purposes of performing this agreement.
