The Applicant hereby agrees to be bound by Enagic® (Malaysia) Sdn Bhd's Set of Policies (including any amendments thereto which shall be furnished to me from time to time).

- 1. Application for Trade Shows request should be submitted:
 - i. at least one (1) month prior to the show;
 - ii. supported by 6A Rank or above; and
 - iii. obtained approval from Enagic® (Malaysia) Sdn Bhd

- 7. Any damage incurred to the 'Banner' and/or 'Loaner Machine', distributor is responsible to make full payment of **RM 250** (Banner per unit zero-rated of GST) and/or The Applicant will have to pay for all the damages resulting from improper use for the Loaner Machine.
- 8. The Applicant is required to fill up the Loaner Machine Request Form should he/she would like to request for the loaner machine.
